Motor Fuels Tax Payment Voucher

DO NOT SUBMIT FORM MFT-V IF A PAYMENT IS NOT DUE OR IF THE PAYMENT WAS REMITTED ELECTRONICALLY.

WHO MUST FILE. Taxpayers owing a payment of less than \$750 for Motor Fuels taxes due on a Form SGS, Form AVFL, Form LO-1, Forms GA-1(R) and GA-1, Forms MF-1 and MF-2, Form MFCO and Form CUL tax return must complete a separate Form MFT-V for each form type and submit it and the required payment with the tax return - unless the payment is made electronically. A Form MFT-V is never required whenever the taxpayer is making an electronic payment.

WHEN TO FILE. A Form MFT-V, and full payment of any tax owed, is due by the original due date of the Form SGS, Form AVFL, Form LO-1, Forms GA-1(R) and GA-1, Forms MF-1 and MF-2, Form MFCO and Form CUL tax return. Late payment of any Motor Fuels tax payment will result in the assessment of applicable interest and penalties.

WHERE TO FILE. The Form MFT-V and corresponding return must be mailed to the address listed below for all Motor Fuels form types.

LINE INSTRUCTIONS FOR PREPARING FORM MFT-V

TAX PERIOD: Enter the last day of the taxpayer's taxable month.

FORM TYPE: Enter an "X" in the appropriate box to identify the form for which payment is being made. Please be mindful that a separate MFT-V must be submitted for each form type.

FEIN: Enter the entity's Federal Employer Identification Number (FEIN).

ACCOUNT NUMBER: Enter your account number assigned to the Motor Fuel form type for which payment is being made.

AMOUNT PAID: Enter the amount of the payment submitted with this voucher.

NAME/ADDRESS SECTION: Enter the legal name of the taxpayer and a complete mailing address for the taxpayer.

ELECTRONIC PAYMENT. Section 41-1-20 requires electronic payments for single business tax payments of \$750 or more. Substantial penalties can be assessed for noncompliance.

Taxpayers making e-payments via ACH Debit must have a Sign On ID and Access Code to login to the Alabama Department of Revenue (ADOR) Paperless Filing & Payment System. Visit our web site at www.revenue.alabama.gov/eservices.htm for additional information.
